HARYANA WAQF BOARD

Notification

No. Waqf-42/(8)/2003/16/Vol.III/1324.— I, Muhammad Akil, IPS, Administrator, Haryana Waqf Board, Ambala Cantt. in exercise of the powers conferred under Section 27 of the Waqf Act, 1995, hereby delegate the following powers to Shri Hanif Qureshi, IPS, Chief Executive Officer, Haryana Waqf Board with immediate effect :-

- (i) To sue and defend cases on behalf of the Board in Civil, Criminal and Revenue Courts and before any authority by engaging advocates for the same and to take proper legal steps concerning Waqf properties.
- (ii) To institute and defend petitions, appeals, revisions, review and execute application in all Courts or before any authority.
- (iii) To convey the formal consent of the Board to any person or authority to institute a suit and to obtain any of the reliefs referred to in Section 83 of the Waqf Act, 1995.
- (iv) To deposit and withdrawn the amounts required to be deposited or withdrawn according to law in respect of suits or proceedings instituted or defended by the Board.
- (v) To take necessary steps for the proper recording of Waqf properties by the authorities appointed by the Government for settlement and consolidation of holdings.
- (vi) Subject to Regulations framed under Section 68 of the Waqf Act, 1954 read with Section 110 and 112 (2) of Waqf Act, 1995 as amended to carry out the day to day administration of the office of the Waqf Board and to exercise the following powers :—
 - (a) Approve tour programmes and sanction TA claims of all employees of the Board.
 - (b) Grant leave of all kinds to all employees of the Board and sanction leave salary.
 - (c) Fix and release salaries of all the employees in the sanctioned Pay Scale.
 - (d) Sanction annual increments to the employees of the Board, except Class-I employees.
 - (e) Sanction up to Rs. 25,000/- at a time for Petrol/Diesel, servicing maintenance/minor repair, insurance and registration of vehicles subject to availability of funds in the budget.
 - (f) Sanction up to Rs. 50,000/- for Postage, news papers, printing & stationery subject to availability of funds in the budget.
 - (g) Sanction up to Rs. 20,000/- for non recurring contingent expenses including expenses incurred on hospitality.
 - (h) Sanction payment of Government dues, 7 % contribution of the Haryana Waqf Board, printing charges of notification in Government Gazette, electricity and telephone bills.
 - (i) Sanction of store items/articles for the use of offices up to Rs. 1,00,000/-.
 - (j) Sanction refunds (except lease money, earnest money and security of building contractor) up to 10,000/ in each case.
 - (k) Withdrawal of Employees' Share from P.F.
 - (l) Sanction up to Rs. 25,000/- in printing and advertisement.
 - (m) Sanction up to Rs. 25,000/- towards Audit expenses, Professional charges, AMC and Insurance of Cash-in-Safe/ Cash-in-transit.
- (vii) Sanction prescribed Court fees and Counsels fees as approved by the Board.
- (viii) To get the accounts of the Board as well as of those Waqfs which are under the direct managements of the Board audited at the end of every financial year as provided in the Waqf Act, 1995 and submit the audit report to the Board/Administrator.

- (ix) To order auction or sanction sales where the original purchase value of movable property of articles does not exceed Rs. 20,000/-
- (x) To receive all the amounts of compensation awarded by any authority in respect of any waqf property after approval of the Board/Administrator.
- (xi) To maintain ACRs of all the employees of the Board.
- (xii) Transfers and Postings of Class-III employees up to the level of Rent Collectors and Imams of Mosques after approval of the Board/Administrator.
- (xiii) Matters concerning Mewat Engineering College (MEC) and other educational institutions of the Board.
- (xiv) Matters concerning National Waqf Development Corporation (NWADCO), Ministry of Minority Affairs, Govt. of India, New Delhi.
- (xv) Matters concerning construction project of Boys' Hostel building of the Mewat Engg. College.
- (xvi) Matters concerning construction project of Girls' Hostel building of the Mewat Engg. College.
- (xvii) To submit recommendations of the Religious Affairs Committee (R.A.C.) for approval of the Board/Administrator.
- (xviii) To submit recommendations of the Adhoc Grant Committee (A.G.C.) for approval of the Board/Administrator.
- (xix) To submit recommendations of the Lease Committee for approval of the Board/Administrator.
- (xx) To submit recommendations of the Committee for Settlement of Court Cases (C.S.C.C.) for approval of the Board/Administrator.
